Sub: Donation for Charitable activities of the Trust – Reg.

The G.S.S.S. Charitable Foundation was formed and registered under the Indian Trust Act on 13.02.2008. The aim of this Foundation among others is to focus on education and training of the economically backward in the Society.

We are conducting 'Free Computer Training Courses' for the unemployed, economically backward and helping in their placement so that they can eke out their livelihood and help their families. So far we have successfully conducted 12 batches of 4 months' duration and trained 185 students and helped them in providing employment wherever possible.

We also grant free scholarships to the children studying in schools and colleges to meet their expenses on uniforms, books, tuition fees etc. We have in the last four years disbursed the scholarships as under:

- ❖ 2008 - for 359 students ---- Rs. 3.38 Lakhs
- ❖ 2009 - for 398 students ---- Rs. 3.76 Lakhs
- ❖ 2010 - for 433 students ---- Rs. 4.25 Lakhs
- ❖ 2011 - for 421 students ---- Rs. 4.22 Lakhs
- ❖ 2012 - for 457 students ---- Rs. 6.20 Lakhs

We propose to disburse scholarship to another 500 needy students involving an expenditure of about Rs. 7,50,000/- in the current financial year.

We are planning to build a Corpus Fund of Rs. 100 lakhs. A few philanthropists have donated Rs. One Lakh each and we have already deposited Rs. 36 lakhs in this "Scholarship Corpus Fund". The aim is to deposit Rs. 100 lakhs so that the interest of Rs. 10 lakhs accrued thereon could be disbursed as scholarship to the needy perpetually. My earnest request is that you may kindly help us to buildup this fund by

donating liberally and help us in the amelioration activities of our Trust for the benefit of the economically backward in the Society. The donations are exempt u/s. 80G of Income Tax Act, 1961.
